A Note from the President

Having just passed our thirtieth anniversary year, GVSHP has taken stock of its past and taken a hard look at its future. Even as we respond to an ever shifting economic climate and changes in technology and communication, we see the need for GVSHP's work continuing to grow markedly.

While the original Greenwich Village Historic District continues in many ways to be at the heart of GVSHP's work, our geographic scope has expanded. Exciting projects and vigorous campaigns by the Society can now also be found in the South Village, East Village, along the Greenwich Village waterfront, in the Meatpacking District, and in Hudson Square. And while landmark designation also continues to be at the core of GVSHP's advocacy work, in recent years we have taken up the mantle of zoning changes, preservation of small businesses, and promotion of theaters and other independent cultural institutions.

The manner in which we reach out to our community has grown too. Our Children's Education program, the first of its kind in the City, is now

taught in schools in all five boroughs, and with a multiplicity of curricula covering not only historic preservation, but immigrant life, building technology, and the changing lifestyle of city dwellers. Our educational programming for adults now includes nearly fifty free or low cost programs each year, ranging from book talks to walking tours, panel discussions to exclusive lectures, film screenings to theatrical performances. Our

semi-annual newsletter the Anthemion has been joined by weekly e-newsletters, a blog, and daily Facebook and Twitter updates. And GVSHP's historic archives have been supplemented by oral histories, video, photos, maps, and other valuable historic resources available through our website, gvshp.org.

As the preservation needs and aspirations of our neighborhoods grow, so does our organization. We've made tremendous strides in the past year, and plan many more in the year ahead.

Last fall, the Archives Committee hosted the exhibit Snapshots in Storefronts: Historic Photos of the Village from the GVSHP Collection, from September 23 to October 29. This unique exhibit showcased twelve historic images from GVSHP's image archive in twelve owner-operated businesses in Greenwich Village. The exhibit included an opening reception at

glassybaby, the candle shop located in the ground floor of the former home of Jane Jacobs on Hudson Street. Attendees were treated to a preview of images in the exhibit and a slideshow featuring 35 other images from the collection. In addition, two guided walking tours led by GVSHP staff member Sheryl Woodruff featured in-depth information about GVSHP's ten different image collections and some fun facts about the hosting businesses.

GVSHP also continued to field regular requests for research assistance and access to the archives over the past year from members of the public, researchers, academics, and students. Each year GVSHP honors people, places, and organizations that have made a significant contribution to the legendary quality of life of Greenwich Village, the East Village, and NoHo. GVSHP invites its members and the public to submit nominations for potential awardees. This past year GVSHP received 115 nominations in a wide range of categories, including individuals, businesses, restaurants and cafes, gardens, restorations, and community groups.

On June 13th, Village resident and author Calvin Trillin presented the Annual Village Awards. The ceremony took place at the GVSHP's Annual Meeting, held at the Village Community School on West 10th Street.

Recipients of the 2011 Village Awards included: Judson Memorial Church, for taking courageous stands and meaningful action for social justice, providing a home for artists, and welcoming everyone without exception since 1890; Annisa Restaurant, for being a pioneer in reviving the tradition of elegant, innovative dining in the Village; Fourth Arts Block, for protecting and

expanding the theaters and the vibrant street life of East Fourth Street over the last decade efforts that culminated in the creation of the East Fourth Street Cultural District; P.E. 
On Sunday May 1, GVSHP presented its 13th Annual Spring House Tour and Benefit. Seven historic townhouses and apartments were featured

A diverse base of membership support continues to be the single largest source of income for GVSHP. Public grants and private foundations continue to be essential sources of support as well, even as funding opportunities in these areas have contracted significantly in recent years.

The organization continued several initiatives to expand and diversify funding and support. GVSHP's children's education program, History and Historic Preservation, encourages students to examine and understand the built environment, enhances their awareness of New York City and its unique communities, and engenders a lively interest in the study of history and the arts. The program offers three curricula: Greenwich Village, Past and Present; Immigration in the South Village; and Streetscape Timeline: Bleecker Street.

700 students in 26 different classrooms from 11 different schools in all five boroughs participated in History and Historic Preservation during the 2010-2011 academic year. Almost half of participating classes benefitted from GVSHP's scholarship program, which offers the program free or at a reduced price to those in need. As we have since 2003, during the summer of 2011 GVSHP offered the program free of charge to the Grace Opportunity (GO) Project at Grace Church School for at-risk students from Lower East Side schools, reaching five fourth grade classrooms. Due to a decrease in city budget funding and an increase in testing preparation, GVSHP, along with other city non-profit education programs, saw a decline in participation.

Finally, GVSHP welcomed our newest educator, Heather Zusman, to the program this year. In addition to teaching for GVSHP, Heather works as a design educator in other city programs such as Learning by Design and Open House New York. She was a project designer for several architecture firms in the city and brings that rich, hands-on experience to the classroom. Heather

joins our veteran educators Jane Cowan, Mary Kay Judy, and Paul Kaplan.

In FY 2010, GVSHP's regular income exceeded budget projections, and expenditures were kept below budget. In addition, the Society was fortunate to receive a very substantial unanticipated anonymous contribution in late 2010, which has allowed GVSHP to expand its staff, programing, infrastructure, research, and community outreach targeted to certain specific projects.

The organization continued to implement best practices in order to ensure the integrity of its finances and operations. This included establishment of an independent audit committee and implementation of a whistleblower policy.

In light of the instability of the financial markets, the Finance Committee continues to review and consider best policies for maintaining its reserves, which are necessary for ensuring the long-term health and survival of the organization. As always, GVSHP aims to avoid deficit spending and does not embark upon major projects unless funding sources for them have been identified.

Working to ensure that our neighborhood's landmark and zoning protections are enforced and, where appropriate, expanded, and that new development is compatible in scale, character, and design with its surroundings, remained a top priority for the Preservation Committee and GVSHP. Educating and engaging the public about our neighborhoods' unique history, the development and preservation issues they face, and research performed upon them by GVSHP were also an important focus of the Preservation Committee.

There were major projects and campaigns in every corner of the neighborhoods GVSHP serves.

In the South Village, following the City's designation of the first third of our proposed South Village Historic District in June of 2010. GVSHP continued to push the City to consider the remaining two-thirds as promised, GVSHP

held a community rally in front of the Children's Aid Society on Sullivan Street this spring to call attention to the threat to these historic buildings from their impending sale. While the City has still not followed through on its promised consideration of landmark designation, the developer who purchased the properties publicly pledged to preserve and re-use the most significant of the buildings, designed by Calvert Vaux.

In the East Village, GVSHP completed a building by building inventory of each structure in the neighborhood. This aided in our successfully pushing the City to expand its two small proposed historic districts to include important adjacent buildings we had fought to preserve, including the 101 Avenue A, and the Russian Orthodox Cathedral and several federal houses on East 2nd Street. Working with fellow community and preservation groups, we helped secure Community Board support for the proposed districts. GVSHP also identified several individual early 19th century houses in the neighborhood which were endangered, calling upon the City to landmark them. This included 35 Cooper Square. 326 & 328 East 4th Street, and 316 East 3rd Street. In spite of strong public support, the City refused to act in all cases. In late October of 2010, however, the City passed the rezoning of

the 3rd and 4th Avenue corridors GVSHP fought for years to enact, imposing new height limits to prevent more of the mega-dorms by NYU and other institutions which had proliferated there.

In the Meatpacking District, GVSHP helped lead the charge against a proposed rezoning to allow massive additions to the historic Chelsea Market complex. GVSHP's advocacy also helped lead to a significant reduction in the size of a proposed addition to 837 Washington Street (at 13th Street) approved by the

Landmarks Preservation Commission.

In late October, the City gave final approval to a rezoning of six blocks in the Far West Village which GVSHP and fellow community groups led a two-year campaign to enact. The new zoning will prevent commercial overdevelopment in the area by imposing height limits and eliminating a zoning bonus for commercial (i.e. hotel) development. As a result, a proposal for a hotel development at Perry and Washington Streets was reduced in

Committee and the organization.

GVSHP also closely monitored plans for a rezoning of the St. Vincent's Hospital site and Hudson Square. The Society has been extremely active around preservation issues in these two areas, and intends to continue its vigorous engagement of both applications, and their public review and approval processes, once they are finalized.

Reviewing plans by government agencies for changes in our neighborhood was an increasing priority for GVSHP. We called for changes to planed redesigns of Astor Place/Cooper Square and the West 4th Street Triangle to better reflect the historic street patterns of the area, to MTA plans for a new Emergency Fan Plant at Greenwich Avenue and 11th Street, and to the pedestrian spaces in the Meatpacking District.

Over the course of the year, GVSHP also reviewed more than one hundred fifteen applications for changes to landmarked sites in our neighborhoods, ranging from storefront alterations to rooftop additions to new buildings. GVSHP also continued to make all of this information available to the public with our Landmarks Application Webpage (www.gvshp.org/lpc), allowing the public for the first time to view this information on-line and plugging them into the

system for public comment and review. This on-line resource has been visited nearly eight thousand times in the past year.

GVSHP also continued to push for enforcement of city regulations which help protect the character of our neighborhoods, such as those restricting the placement of billboards, or requiring adequate maintenance of landmarked buildings, such as 43 MacDougal Street and 151 West 13th Street.

Finally, early this year GVSHP launched its blog, "Off the Grid," which provides a new forum for sharing news and historic information about our neighborhoods, as well as providing an opportunity for feedback and engagement. Since its launch in February, the very successful blog has had nearly ten thousand views.
